# VOTING AND ELECTION REFORM: A PRIORITY FOR LEAGUE



Last fall, the League of Women Voters of New Jersey was a lead organization ensuring the passage of automatic voter registration legislation in New Jersey. In the coming year, the League plans to advocate for legislation that will continue to increase voter participation.

According to **state league President Nancy Hedinger**, "our state is falling behind when it comes to access to the ballot, and we cannot wait any longer to correct our shortcomings. We will continue working in partnership with the Governor and the Legislature to break down arbitrary barriers to voting and pass and implement strong policies that include online and sameday voter registration, in-person early voting, allowing certain 17-year olds to vote in primary elections, and restoring voting rights to people with criminal convictions. We will also continue advocating for voting machines that produce a voter-verified, auditable paper trail in

order to further safeguard the integrity of our elections."

In January and February, the state league conducted and/or participated in forums that reviewed what current state (legislative) redistricting process is, identified best practices for redistricting, either proposed or undertaken in other states, and obtained feedback on what principles and policies attendees would like to see enacted in NJ.

Last December, there was a massive public outcry against the flawed redistricting proposals state legislators were close to enacting. The League hopes redistricting reform will be transparent, inclusive and put more power in the hands of voters.

If enacted, new legislation introduced in the U.S. House of Representatives, HR1 (For the People Act), will modernize our election system, reform redistricting, and restore the Voting Rights Act. As the legislation includes many election reform pieces that are consistent with core principles of the League, the national office is an active coalition partner in helping to shape the language of the bill.



Currently, the bill contains no provision to reduce the undue influence of <u>Big</u> <u>Money in elections</u>. It is also unclear how much support the legislation will have in the U.S. Senate.

# LWVUS UN OBSERVERS PREPARE FOR THE 63RD MEETING OF THE COMMISSION ON THE STATUS OF WOMEN


LWVUS UN Observers are preparing for the 63rd Meeting of the Commission on the Status of Women at the United Nations in New York on March 11-22, 2019.

The Commission on the Status of Women (CSW) is the principle global intergovernmental body exclusively devoted to promoting women's rights, documenting the reality of women's lives throughout the world, and shaping global standards on gender equality and the empowerment of women. There are about 20 League delegates who will attend a minimum of 4-5 days of CSW and will partici-

pate in all varieties of sessions including commission meetings and side events.


