

Although I am an intern volunteering with the League of Women Voters of Northern Valley, my knowledge of voting customs in the General Election and the unprecedented COVID-19 practices were slim at best. I sought guidance from my parents, who I learned were just as confused as I. No one was telling us the protocol for voting during a pandemic. No one was telling us in-person voting would be cancelled in Bergen County. And most importantly, no one was telling us about the views of candidates on local issues, which had become inaccessible through the isolation of quarantine.






